## Training Programs Revised and Fall Courses Offered

The Education Advisory Committee for the Planning Board/Zoning Board Secretary and Zoning Official training programs met several times over the spring and summer and made some significant content revisions.

The program for Board Secretaries still comprises 33 classroom hours, but the subject matter emphasis has been shifted. Introduction to Planning and Zoning Administration remains much the same and still involves 16 classroom hours. The Financial Management and Records Management courses have been combined into a single six-hour course, and Understanding Plans has been expanded from a six-hour to a ten-hour course. Those interested in a Planning Board/Zoning Board Secretary certificate must still successfully complete two examinations. The first exam is given at the conclusion of the



Introduction course, and the second exam, covering financial management, records management and plan-reading topics, will now be given at the conclusion of Understanding Plans.

Similar changes in the Zoning Official certificate program will be implemented during the Spring 2005 semester. Understanding Plans for Zoning Officials will be expanded to 1½ days and the Zoning Administration and Enforcement II course

## Spring Seminar on Land Use Draws Crowd

On June 4, 2004, NJAPZA and Rutgers co-sponsored a day-long Continuing Education Seminar that attracted over 120 registrants from around the State. Those in attendance holding a Board Secretary, Land Use Administrator or Zoning Official certificate received five hours of continuing education credit and heard four different land use issues discussed.

The annual report of the Zoning Board of Adjustment was the focus of the first panel, which was moderated by Ilene Cutroneo, Administrative Coordinator for the Princeton Regional Planning Board and NJAPZA President. Princeton Mayor Phyllis Marchand, Princeton Township Zoning Board of Adjustment Chair Carlos Rodrigues and

Princeton Regional Planning Board Vice Chair Victoria Bergman joined Ms. Cutroneo to discuss the use of the annual report as a planning tool and the process by which the report is developed as well as its impact on land use policy and legislation in Princeton Borough and Princeton Township.

To round out the morning, Lou Rago, Esq., a land use attorney with Weiner Lesniak and NJAPZA Counsel, presented his annual review of important land use case law. He provided a lively analysis of 19 Law Division and Appellate Division court cases, both reported and unreported, and offered his insights about the significance of each case.

During the afternoon breakout sessions,
